INDIVIDUAL SCHOOL, UNIVERSITY or ORGANIZATION
LICENSE AGREEMENT**

THIS LICENSE is to a **named** individual school, an individual learning center, an individual university department, or an individual department or unit of an institution, or an individual department or unit of an organization who is **named** as the registered SOLE user of the *Bannatyne Reading, Writing, Spelling and Language Program*.

ARTICLE 1: LICENSE GRANT

The *Bannatyne Reading, Writing, Spelling and Language Program*, the entire contents of the CD-ROMs and all included materials including all printouts and copies are the intellectual property of Alexander Donald Bannatyne PhD and are protected by law, including United States copyright laws and international treaties and agreements.

As the authorizing officer of an individual school, learning center, university department, institution or organization Alexander Donald Bannatyne PhD grants the named registered user a license on condition that,

1. You agree your named **individual** school, learning center, university department, institution or organization shall use this licensed copy of the *Bannatyne Reading, Writing, Spelling and Language Program* or print out from this licensed copy **only** for the purposes of teaching students, demonstration or teacher training.
2.
